

**COMBINED NOTICE OF FINDING OF NO SIGNIFICANT IMPACT and
NOTICE OF INTENT TO REQUEST RELEASE OF FUNDS**

These notices shall satisfy two separate but related procedural requirements for activities to be undertaken by the North Carolina Housing Finance Agency.

REQUEST FOR RELEASE OF FUNDS

On or about **December 2, 2024** the North Carolina Housing Finance Agency will submit a request to the HUD/Greensboro Field Office for the release of HOME-ARP Funds/Supportive Housing American Rescue Plan (“Program”) under the HOME Investment Partnership Act, 42 U.S.C. §12701, et seq. (“HOME”) and Section 3205 of the American Rescue Plan Act of 2021 (P.L. 117-2) (“ARP”) in accordance with the HOME regulations, 24 C.F.R. Part 92, as amended and modified by ARP (hereinafter HOME and ARP are jointly referred to as the “Act”); to undertake a project known as Oakwood Park, for the purpose of constructing a 16 unit affordable housing apartment complex for low to moderate income households. The project will consist of the new construction of a two-story apartment building with four 1-bedroom units, eight 2-bedroom units and four 3-bedroom units. The building will be 18,792 square feet. The site will be located at 2943 W Vandalia Rd, Greensboro, NC 27407 and is approximately 1.25 acres. Project activities, occurring over an anticipated 2-year period, will include land acquisition, site preparation, utility installation, and construction. The total estimated cost for this project is \$4,339,104.00 with approximately \$2,603,462.00 (60.0%) contributed from federal HOME-ARP funds under the Act.

FINDING OF NO SIGNIFICANT IMPACT

The North Carolina Housing Finance Agency has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. Additional project information is contained in the Environmental Review Record (ERR) on file at The North Carolina Housing Finance Agency, 3508 Bush Street, Raleigh, NC 27609 and may be examined or copied weekdays 9 A.M. to 4 P.M.

PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to Scott Farmer, Executive Director, North Carolina Housing Finance Agency, 3508 Bush Street, Raleigh, NC. All comments received by **December 1, 2024** will be considered by the North Carolina Housing Finance Agency prior to authorizing submission of a request for release of funds. Comments should specify which Notice they are addressing.

ENVIRONMENTAL CERTIFICATION

The North Carolina Housing Finance Agency certifies to the HUD/Greensboro Field Office that Scott Farmer in his capacity as Executive Director consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. The HUD/Greensboro Field Office’s approval of the certification satisfies its responsibilities under NEPA and related laws and authorities, and allows Affordable Housing Management, Inc. to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of funds and the North Carolina Housing Finance Agency's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases:

- (a) the certification was not executed by the Certifying Officer of the North Carolina Housing Finance Agency;
- (b) the North Carolina Housing Finance Agency has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58;
- (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or
- (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality.

Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to:
